**JOB ANNOUNCEMENT: ASSISTANT ATTORNEY GENERAL, CIVIL DIVISION**

The Office of the Attorney General, Ministry of Justice, Republic of Palau, is seeking a licensed attorney to serve as an Assistant Attorney General (“AAG”) in the Attorney General’s Civil Division. This position reports to the Chief for the Civil Division, representing the Republic in civil litigation and appeals, and providing advice and counsel for the Republic and its Ministries.

As a Freely Associated State, the Republic’s legal system is largely consistent with that of the United States, and U.S.-based attorneys or those with practice experience in U.S. courts are encouraged to apply.

**QUALIFICATIONS:** J.D. from an ABA-accredited law school or a law degree from a law school accredited by the prevailing accrediting agency of the jurisdiction;

An active member in good standing of the bar (any jurisdiction);

Strong writing and analytical skills;

Experience with motion practice, oral advocacy;

Collegial and well organized;

Demonstrated experience supervising and training junior attorneys is required;

(Preferred) Minimum of 1–5 years of civil legal practice, with an emphasis on litigation and appellate experience.

**DUTIES & RESPONSIBILITIES,** a Civil AAG is responsible for:

Representing the Republic of Palau and its Ministries and Agencies in a wide range of civil litigation matters;

Handling, as needed, appeals of trial court decisions; and

Providing such legal advice and services as appropriate and directed by the Attorney General.
