

GENERAL RELEASE FROM LIABILITY

In consideration of my participation in Marin Scuba Club ("MSC") activities, I hereby fully release and discharge MSC, its officers, directors, members, course instructors, dive trip leaders, boat owners and skippers, drivers, agents, attorneys and their heirs, successors and assigns (the "released parties"), from any present and future claims, actions and damages, of any kind and nature, including negligence, property damage, personal injury, or wrongful death, arising from my participation in MSC related activities, including, but not limited to social activities. This release includes, but is not limited to, all compensatory, non-economic, consequential, incidental, and punitive damages.

PLEASE READ AND INITIAL ON EACH LINE BELOW

I am aware that snorkeling, free diving, skin diving and scuba diving, kayaking, boating and other clu activities (collectively, "Water Activities") take place in unconfined waters such as oceans or lakes. Such water are subject to current, waves, surge, cold and wind and Water Activities therefore can be hazardous activitie I voluntarily participate in Water Activities with knowledge of the dangers involved and hereby agree to accept and assume any and all risks of property damage, personal injury and death.
I am aware that such recreational and/or social club activities that do not involve Water Activities ("Out of Water Activities") may take place adjacent to unconfined waters such as beaches or lakesides, tidal pools, shoreline paths, rocky and sandy surfaces or adjacent to swimming pools and swimming pool surrounds Beaches, tidal pools, shoreline sands and lakesides are subject to current, waves, surge, cold and wind and the shorelines can be hazardous. Swimming pool surrounds can be subject to slipping, falling on the surface or into the swimming pool or other hazards. I am voluntarily participating in activities adjacent to unconfined waters, such as beaches and lakesides, or confined waters, such as swimming pools, with knowledge of the dangers involved and hereby agree to accept and assume any and all risks of property damage, personal injury and death.
I understand and agree the purpose of Out of Water Activities of MSC are strictly recreational and that it is not the function of the participants or leaders to serve as the guardian(s) of my safety.
I understand that Water Activities and Out of Water Activities, including, but not limited to social activities, involve certain risks, including but not limited to, travel to and from the site of the activity, possible negligent or reckless conduct of other participants, serious injury or death resulting from drowning, near drowning, arterial air embolism, decompression sickness (DCS), collisions with boats, propellers, and vehicle entanglement with kelp or fishing line, hypothermia, wave and surf-related injuries, and contact with dangerous marine life. I am voluntarily participating in Water Activities and Out of Water Activities with knowledge of the dangers involved and hereby agree to accept and assume any and all risks of property damage, personal injury and death.
I am aware that Out of Water Activities may take place in, on or adjacent to unconfined waters such a beaches or lakesides, tidal pools, shoreline paths, rocky and sandy surfaces or adjacent to swimming pools an swimming pool surrounds. Beaches, tidal pools, shoreline sands and lakesides are subject to current, waves



I agree to defend and hold harmless the released parties from any claim against them, which may arise in
whole or in part from my acts or omissions while participating in any MSC activity.
I agree that this GENERAL RELEASE OF LIABILITY release shall be binding not only on myself, but on my heirs, executors, conservators, personal representatives, successors, agents, and assigns.

I expressly waive any rights or benefits available to me under the provisions of Section 1542 of the California Civil Code, which provides as follows:
